# Nevada Indian Commission Civic Engagement Advisory Committee Report Meeting: January 29, 2024

## Introduction:

The Nevada Indian Commission, pursuant to NRS 233A.100, Powers of Commission, is authorized to appoint advisory committees whenever necessary or appropriate to assist and advise the Commission in the performance of its duties and responsibilities. At a meeting duly held on July 21, 2023, the Commission authorized the formation of an advisory committee on civic engagement.

The purpose of the Nevada Civic Engagement Advisory Committee (CEAC) is to support our 28 Tribal Nations, Bands, Colonies and our 62,000 Urban Indians in building a statewide ecosystem of nonpartisan civic education and engagement focused on Native American affairs.

CEAC will meet regularly to discuss all aspects of civic engagement including the the U.S. Census, redistricting, voter registration, education and engagement; election services and navigating the Nevada Legislature. As a state agency, the Commission must stay neutral and nonpartisan, our NIC leadership's aim is to ensure that our people have access to accurate and timely information and resources to support these efforts.

### Report

To launch the NV Civic Engagement Advisory Committee, NIC partnered with the <u>Native</u> <u>Organizers Alliance</u> (NOA), a national Native-led, nonpartisan organization that provides capacity building training, rooted in traditional values, for Native leaders and organizations both in rural and urban communities. The training was held September 20-22, 2023 on the Stewart campus.
